

## COLD SPRINGS IMPROVEMENT DISTRICT REGULAR BOARD MEETING OCTOBER 6, 2016

#### A. CALL TO ORDER

District Manager Peter L. Pimentel called the October 6, 2016, Regular Board Meeting of the Cold Springs Improvement District to order at 10:05 a.m. in the Conference Room of Gray, Ackerman & Haines, P.A., 125 NE First Avenue, Suite 1, Ocala, Florida 34470.

#### B. PROOF OF PUBLICATION

Mr. Pimentel presented proof of publication that notice of the Regular Board Meeting was published in the *Star Banner* on September 16, 2016, as part of the District's 2014/2015 Fiscal Year Regular Meeting Schedule, as legally required.

#### C. SEAT NEW BOARD MEMBERS

Mr. Pimentel announced that at the last Landowners' Meeting, which preceded this meeting, Ms. Brenda Bibb and Mr. Bryce Ackerman were elected as Members of the Board. He noted that they were in attendance and it would be in order for them to take their seats as newly elected Board Members.

#### D. ADMINISTER OATHS OF OFFICE

Ms. Bibb and Mr. Ackerman executed their respective Oaths of Office which were duly notarized.

## E. ESTABLISH QUORUM
